ADOPTEES AND THEIR FIRST BIRTH CERTIFICATE

Family Court judges in this state recently have signed Orders permitting their adult adoptees to acquire a copy of their first birth certificate. The number of these requests appears to be increasing not only in this state but across the United States.

These states that have enacted legislation allowing adult adoptees to see their first birth certificate are: Maine, New Hampshire, Alabama, Oregon, Illinois, Tennessee, Georgia and Kansas.

Rhode Island enacted this legislation, but with the condition that the petitioner must be twenty-five years of age. Just this year, the state of Colorado passed an act that allows every adult citizen to see their first birth certificate.

The state of Washington legislators enacted this legislation, but added this caveat, "unless the birth parent has filed an affidavit prohibiting release."

New Jersey passed this new act, but it does not go into effect until 2017. The state gave biological parents until January 1, 2017 to redact their names if they choose.

In Indiana, an adoptee must wait until the birth mother is deceased. These states will allow access with a court order: Kentucky, California, and North Carolina.

Since the 1930s, New York state has denied all adoptees access to their original birth certificates. In June of 2014, its legislature again debated a bill to give all adoptees access to their original birth certificates but there were not enough votes for it to pass.

"My original birth certificate sits in a building in New York and I am not entitled to it," quoted Maureen Sheridan in the New York Times in June of this year. "Adoptees in New York can also seek their biological parents through the state's mutual consent registry – but critics say doing so rarely results in a match," added that newspaper.

In response to that N.Y. newspaper story, letters from adoptees were printed.

"This isn't about balancing rights of parities. Adopted people have a right to their full identity, like every other American...This is about people who had no say and in their adoption simply having a right to know who they are, to know their genetic heritage."

Another letter to the editor said, "New York's out dated approach to adoption amounts to a violation of adoptees' civil rights...It is highly unlikely that confidentiality was promised by the officials involved."

"It is generally agreed that most jurisdictions would allow access via court order even though some standard must be met to obtain the order, such as a "compelling need," said Thomas P. Lowndes, Charleston adoption attorney and former president of the U.S. Academy of Adoption.

That statement by Lowndes refers to the 1981 case of <u>Bradey versus Children's Bureau of South Carolina</u>. S.C.21378. 274 S.E. 2nd. 418 in which the Court held that a "showing of "good cause" was required of the plaintiff to make a "demonstration of compelling need for identifying information."

It appears that some Family Court judges in this state at this time are not requiring a stringent definition of a "good cause."
