If you have the case number, please email or call the clerk directly based on the ending number of the case, or alternatively you may call our main numbers. We will continue to offer this service as long as the building is open.

The Charleston County Probate Court will continue to accept filings, pleadings, motions, applications, etc. through the mail, email, and by drop off at the probate court offices. The Charleston County Probate will serve our citizens by phone, video conferencing, email, online, texting, and regular mail. Civil commitment hearings will be via video conferencing. The Charleston County Probate Court will hear all emergency matters. Drug Court, Mental Health Court, and Veterans Treatment Court sessions are postponed. *With the exception of this week's scheduled hearings, the Charleston County Probate Court will hear all non-emergency cases after the pandemic ends.*

For Marriage Licenses, we are looking to create an on-line Marriage Application process in order to assist couples who are getting married in the next 30 days. We will let you know once this has been established.
